2. Reason

The Company's basic policy is to place the priority on growth investments, while taking the financial conditions into account when determining dividend payouts to its shareholders.

Based on this policy, the Company has decided to return profits to shareholders in the form of dividends for the fiscal year ended March 31, 2020.

Consequently, the Company plans to pay a year-end dividend of 8.5 yen per share for the fiscal year ended March 31, 2020.
